### 71 Sleepy Hollow Road

Mr. Frankiewicz presented plans for the proposed work to be done at 71 Sleepy Hollow Road, U01-Lot 4. The property owner wants to replace 175 feet of the wall with concrete blocks. A Dredge and Fill Permit was obtained from the State of NH. The Commissioners reviewed the plans presented.

The Commissioners have no concerns about the proposal.

### **Town Timber Harvest Update**
