**I. Review and Adoption of minutes 5/29/2019**

**II. OM Brochure Discussion and Review**

Deb recommended changes and rearrangement of brochure material. Following discussion, Meadow will make changes as discussed and forward to committee members for review.

Deb - Everyone must sign the Volunteer Service Agreement and provide to Nancy at the Town Office if they are working on the OM. A copy should be maintained on site. Virginia and Meadow will provide folder/binder with necessary forms and copies of signed forms to be kept at the OM.

The General Release form is for contractors doing work at the OM.

**VII. OM One Time Event Update**

Chuck met with Joel French of the fire department as Joel will be providing a letter identifying what would be required to have a onetime event at the OM.

**VIII. Other**

Val – Suggested that someone should talk to the Nutter family about a donation. Virginia will talk to them about involvement.
